Remarks on the min. standards made on T.F.-meeting in Damme, March 1990 :

E. 250 hours of own experience.

Criteria had to be worked out to make an evaluation of personal therapy.

Co-leading and supervision had to be determined by the local association.

2 T.F. must determine with each other when somebody is ready with personal therapy, co-leading, supervision.

For evaluation of co-leading and supervision - criteria had to be worked out.

Each association had to work out the criteria of evaluation of

- personal therapy ;

- co-leading.

F. Supervision criteria :

When is somebody ready to run groups by him-/herself. This had to be worked out too by each local association.

Doing the evaluation of each phase of the training program before going to the next phase, by the local association is a good point.

3. Criteria for T.F. : (Remarks Newsletter Oct. 1987 p. 7).

1) Masters degree on an academic level in human sciences.

2) 3) Sponsored by 2 T.F. (from one or another association or country).

4) The candidate who asked a T.F.-ship had to be published in advance in the newsletter. Every T.F. can give his remarks.

5) To be fellow at least 5 years.

6) 7) To become T.F. they have to follow a special training ; exp. in Germany. Special training group with regular supervision-meetings led by 2 T.F.
